

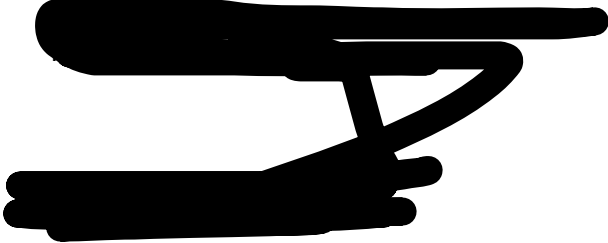

Dear Friends,

Unfortunately while a DDP is of the essence, until we own all the land needed for the Auroville project it will offer little protection from encroachment from unwanted project within the Master Plan.

The acquisition of all the land needed to realise Auroville is the upmost priority at this point. With Paul we can only regret that the funds to purchase these land have not been forthcoming from the GOI.

If the responsibility does not solely fall on the Governing Boards; after all land purchase is the responsibility of the FAMC, who has neither established priorities for land purchase, or outlined the amounts that will be needed to buy these land, it is also the role of the Governing Board “to ensure the development of Auroville as planned”.

There is of course no need to create discord, or a polemic, but as the Governing Board is currently meeting in Auroville it certainly should be reminded that, in that instance, it is hard cash that is needed rather than word.

In stead of discussing about the Master Plan, one should rather talk about the failure of the Auroville Foundation to protect and foster Auroville as enshrined in the Auroville Foundation Act...

Powers and functions of the Governing Board

17. The powers and functions of the Governing Board shall be-

(e) to prepare a master-plan of Auroville in consultation with the Residents' Assembly and to ensure development of Auroville as so planned;

Now, in 1999, the Residents Assembly of Auroville has approved the Master Plan and in the same year, the Governing Board has also approved the same... However, there is a total lacuna from the Governing Board to "***ensure***" the development as planned. No fund has ever been generated by the Governing Board to purchase or secure the required lands needed for the Master Plan. No fund has ever been provided by the Government of India to secure the lands needed for the implementation of the Master Plan... All sort of pretexts are given for this failure which will generate a total incapacity to realize this approved Master Plan... We have been left to ourselves to solicit private donations; this was too little. Since 1999, many unregistered layouts and private developments have taken place unabated in the Master Plan area, these make it impossible to realize the socio-economic ideals expressed by Mother and enshrined in

the Auroville Charter...
